# **TERMS OF SERVICE / AGREEMENT**

This Terms of Service Agreement (the "Agreement") is between you ("you") and Ambulance Access for All Foundation, India.

AAAF is a registered "Not for Profit Organization", established in 2005, with the intention of providing world class ambulance service based on technology and trained professionals irrespective of income class in India.

Life Supporters Institute (LIHS) is a registered "Not for Profit Organization", established in 2005, with the mandate to conduct emergency and critical care education and to create a cadre of trained pre hospital healthcare professionals to raise funds for the welfare of ambulance crew and their families.

April – June 2020 Fund Raise - The current initiative / fund raise is to support healthcare and ambulance workers who are more prone to get infected while working on the frontline in the battle against Corona. The funds raised will be used to support the frontline healthcare workers to meet medical and other emergencies, both Covid-19 related and otherwise, of themselves and their immediate family members.

AAAF and LIHS are leaving no stone unturned in trying to include as many individuals and organizations to raise funds for frontline healthcare and ambulance staff and their family's welfare. The key beneficiaries of this fund raise will be the frontline healthcare and ambulance workers.

This document is an electronic record in terms of Information Technology Act, 2000 and rules there under as applicable and the amended provisions pertaining to electronic records in various statutes as amended by the Information Technology Act, 2000. This electronic record is generated by a computer system and does not require any physical or digital signatures.

# 1) Principle Rules

For the purpose of this Agreement the term "Campaign" shall mean the initiative by AAAF to raise funds to provide for medical and other emergency support to frontline healthcare and ambulance staff and their families who are at risk of being infected due to transfer of patients of Covid-19 and other patients during the Covid-19 pandemic.

## 2) Eligibility:

You are eligible to make a donation towards the campaign, subject to these terms and conditions if,

- (i) you have attained the age of majority i.e. eighteen (18) years.
- (ii) you are a company / partnership / proprietorship / not for profit registered under the laws of India and resident (for applicable laws) in India
- (iii) you are any other entity duly registered / incorporated under the laws of India and resident (for applicable laws) in India
- (iv) you are a resident in India at the time of Donation towards the Campaign
- (v) you are making the donation in Indian Rupees

#### 3) Acceptance of Terms and Supplementary Terms:

AAAF accepts the donation subject to this document, including the privacy policy and any additional guidelines, rules, terms and conditions, each of which is available in the website of AAAF or the campaign page on Ketto.org or any other platform / medium through which the campaign reaches you.

By making / donating a payment to this campaign, you acknowledge and agree that you are an individual and that you are accepting this Agreement and are bound by this Agreement or that you are an individual accepting this Agreement on behalf of an agency or entity, and you warrant that you have the legal right to accept this Agreement on behalf of such agency or entity and that the agency or entity will also be bound by this Agreement.

#### **Modes of payment:**

The donations towards the Campaign shall be made in the name of AAAF commencing from 22<sup>nd</sup> April 2020 till to 31<sup>st</sup> May 2020 ("Period"). Donation can be made in the following modes:

- a) Payment Via Cheque During the Period, you can make Donations via cheques in favour of "Ambulance Access for All Foundation". You are also required to provide your name, mobile number, PAN Card number on the backside of the cheques and drop the cheque at the nearest branch of the Bank.
